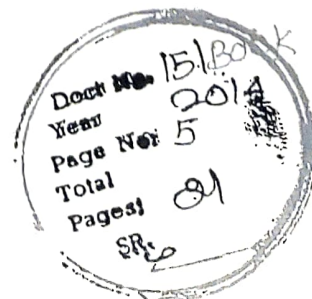
- a) The Trust shall be called "ST. ARULANANDAR EDUCATIONAL TRUST" hereinafter for the sake of brevity called "The Trust".

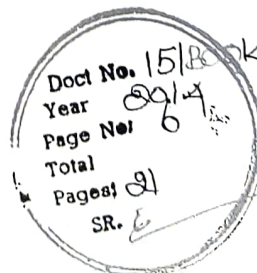

9. To promote and advance moral educational, charity, family welfare and general welfare of the people.
10. To give food, clothing, medicines, cash grants and any other help that may be necessary to the poor and afflicted people in distress, affected by natural calamities such as earthquake, floods, famine, etc..

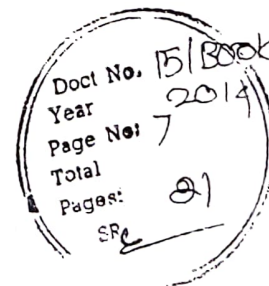
- d. The amendments of Trust Deed shall be carried out with previous permission of Commissioner of Income Tax. The amendments to Trust Deed shall not contravene sections 2 (15), 11, 12, 13 and 80-G of the Income tax Act, 1961 and comply with requirements of the said section and law.
- e. It is hereby declared that no amendment to the Trust Deed shall be made / carried out except with the prior approval of the COMMISSIONER OF INCOME TAX, However, the amendments to be carried out shall not infringe the provisions of the income tax act, 1961.
- f. The object of the Trust shall be carried out only in India.
- g. Proper books of account shall be maintained by the founder Trustee of the Trust on a financial year basis and it shall be audited by a chartered accountant once in a year. The accounts of the Trust shall be closed annually on 31<sup>st</sup> March every year.
- h. It is hereby declared that the Funds / Income of the Trust shall be solely utilized for achieving the objects of the Trust and the Funds / Assets of the Trust will not be utilized for payment of Trustees / Office bearers or members of the committee or their relatives by way of profit / Dividend / Interest / Bonus etc., directly or indirectly.

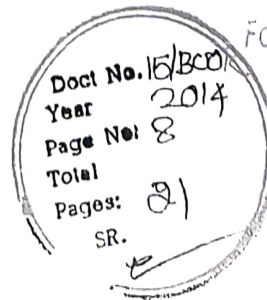
- j. The Trust shall exist for PUBLIC CHARITABLE PURPOSES AND SOCIAL WELFARE ACTIVITIES and not for the purpose of profit motive.
- k. The benefits of the Trust are open to all Indians irrespective of Caste, Religion, Community, Creed, Colour, Language or Sex or other differences and no income of the trust shall be applied for the personal benefits of the Founders / Trustees / Members / Their Relatives / the members of the family and employees of the trust.
- l. The trust shall not have any movable and immovable properties as on date.

#### THE ADMINISTRATION, MANAGEMENT AND POWER OF THE TRUSTEES

1. The first president of the board of trustees shall be the founder A. JOSEPH JOHNSON who shall be the Managing Trustee and hold office till his life time. The founder cum president hereby appoints secretary, vice secretary, treasurer and other members.
2. All these office bearers shall hold office till they enjoy the confidence of the founder. In case, the founder during his life time desires to nominate any body else to the offices for if he desires to include more trustees for the effective management of the Trust, he shall be entitled to do so and for the same he has got unfettered power.
3. The other Trustees will act as trustee for the period of two years from this date. They may be reappointed for the further periods or invitation by the Managing Trustee.
4. In case of any vacancy arising in the trust by death or resignation or otherwise the remaining trustees will have full power to represent the trust board.

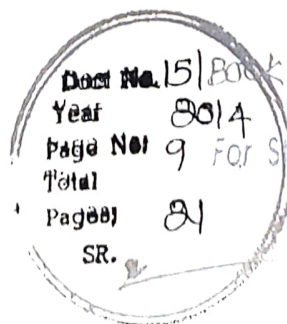
5. If any of the trustees other than the founder does or do any act which is derogatory to the aims and object of the trust, he shall be removed by the board of trustees by a majority opinion and for the vacancy so caused, the trust board can nominate any other person as Trustee if such person has got the interest and involvement in the objects of the trust.
6. The administration of the trust shall be generally vested with the board of trustees. However any specific administrative or executive power can be vested in founder only by passing a resolution in any meeting of the board of trustees.
7. The trustees may transact any business by circulation or by periodical meeting at the office of the trustees or any suitable place that may be found convenient by the president then and there and quorum of the meeting shall be two.
8. While transacting the business, if disputes arise it shall be decided by a majority of votes and incase equity of votes, the president shall cast a second or casting vote.
9. A meeting of the trustees for the time being at which quorum is present shall be competent to exercise all or any of the authorities, powers, discretion by these presents vested in the trustees, generally.
10. The members may receive donations in cash or kind including movable or immovable properties, but all such monies, properties when received shall vest in and shall be at the absolute disposal of the trust.



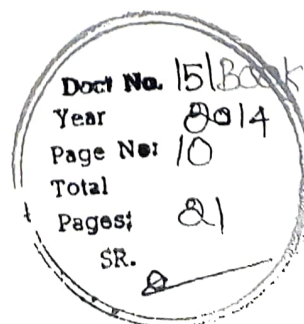

11. The founder A JOSEPH JOHNSON will act as the Managing Trustee of the board without prejudice to the rights and obligations to the Trustees contained here shall have all and every power the purpose of Managing, Conducting and administering the affairs of the trust or the institutions created by the trust on behalf of the members of the trustees.
12. 13. The Managing Trustee shall have the power to acquire, purchase, sell convert or otherwise release of any trust movable or immovable properties and invest in the same form of investment or change the form of investment where they are satisfied that such investment will yield a reasonable income or where it is deemed expedient or necessary for carrying out the objects of the trust and such investment will be in accordance with rules prescribed by the Income Tax Act, 1961 as amended from time to time. 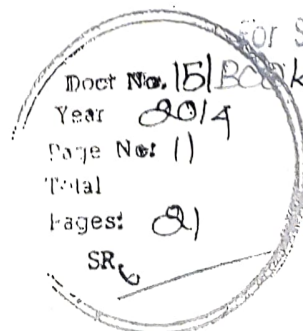

14. 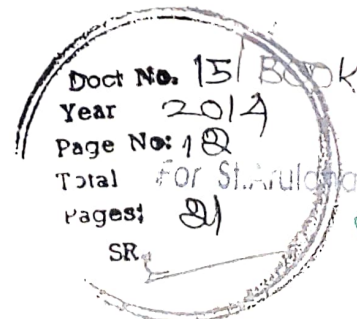

- C. To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they think fit for the purposes.
- D. To withdraw any power or revoke any appointment of any employees or attorneys.
- E. To let any portions of any immovable property to be acquired in future without profit motive and forming part of the trust fund conditions as they think fit to attain its object and to accept surrender or any letters.
- F. To borrow money with or without security or **pledge mortgage**, or otherwise charge any of the properties, belonging to the trust for the purposes of raising loan.
- G. To determine who shall be the first named as **regards investments** in shares, stock, debentures and other securities and other investment.
- H. To appoint individual or group of person to take care of the management of the trust property or properties.
- I. To take on lease or acquire property by purchase or otherwise to promote of the objects of the trust.
